# Exporting and Importing of Goods Including International Legislation - Introduction

Please be prepared to provide your residency documents such as a passport, EU citizen ID card, UK Birth Certificate or Biometric Card. If you have been in the UK for less than 3 years or have entered the UK with a visa you will need to provide evidence that you are eligible to study in the UK - your visa, your biometric card that covers the duration of your course or any relevant home office documents to support your residency should all be uploaded.

If you're an EU, EEA or Swiss citizen we will need to see evidence of 'Pre-Settled' or 'Settled-status' documents. Also for funding purposes we would need to see evidence of payslips if working (within the last 3 months). If you are receiving benefits (e.g JSA, ESA, Universal Credit (UC), Housing benefits etc. please bring evidence of this).

## **HOW WILL I BE ASSESSED?**

You will be required to do assignments and tasks in class and home study, able to meet deadlines and respond to tutor feedback so that your assignments are to a level 2 standard.

You may progress on to further studies.
